VERIFICATION OF LEGAL RESIDENCY

To be enrolled in an SAU 40 school, student must reside in Milford or Mason (Grades 6-12), New Hampshire. New Hampshire State Law states that no student who lives outside the district may attend school without consent of the School Board. The fact that an individual pays taxes to a district but has an established residence elsewhere does not extend the privilege of attending local schools.

Schools in SAU 40 include: Jacques Memorial Elementary School, Heron Pond Elementary School, Milford Middle School, and Milford High School.

If a student registers in an SAU 40 school and is found to live outside of the district, the parent or guardian may be held responsible for payment of tuition proportionate with the number of days in attendance. If at any time during the year there is a change in family status, such as divorce, marriage, or a change in guardianship, parents are required to contact the school and provide legal documentation of these changes. The school district may request residency documentation at any time during the school year.

Parents who intend to move into the community during the school year may request enrollment of their children prior to the establishment of residence, giving written notice as to the anticipated date of residence per policy 5055 (JFA).
